AIC Ltd. (" we", " us" or "AIC"), is an international business company registered in Saint Lucia under registration number: 2023-00068. We help traders and Introducing Brokers achieve their business goals and personal ambitions. Our business is built on integrity and trust, offering an industry leading combination of dynamic products, competitive trading parameters and premium, one- on-one service.

It is AlC 's mission to enable the personal ambitions and business goals of FOREX traders and IBs, through underpinning dynamic products with competitive trading parameters and a premium customer experience.

2. COMMITMENT

AIC is committed to protecting the privacy of all personal information which it obtains from you, including the information obtained during your visits to this website or the provision of other services to you. AIC will only use your personal information in accordance with this Privacy and Security Policy and otherwise in accordance with the Privacy and Data Protection Act in Santa Lucia.

3. AI Copier COLLECT PERSONAL INFORMATION

AlC collects certain personal information in order that it may meet the needs of its customers. By collecting certain personal information, AlC can monitor and improve the services which it offers to its existing and potential customers

. We will use this information for the following purposes: establishing and maintaining your account, providing our services to you, improving our services, regulatory notifications and marketing.

4. WHAT INFORMATION DOES AI Copier OBTAIN?

- to create anonymized statistical data.

You consent to AlC using your personal information for the above- stated purposes. You also consent to AlC transferring your personal information out of Saint Lucia where this is necessary for AlC to fulfill its contractual obligations to you. Please note that AlC only transfers personal information to organizations out of Saint Lucia if AlC has assessed the organization as having appropriate controls and safeguards in place to protect your personal data.

6. WHO MAY AI Copier DISCLOSE THIS INFORMATION TO?

AIC may be required to provide your personal information to the regulator and government bodies from time to time. AIC may also disclose your personal information to:

- financial institutions and other similar organizations that ideals within the course of its corporate activities, or those that are nominated by you.
- external service providers and professional advisers (which may be located overseas) that provide services to AIC .
- any organization at your request or any persons acting on your behalf, including your financial adviser, broker, solicitor or accountant.
- any third parties where this is necessary to process a transaction or provide services which you have requested; or
- any authority to whom AIC is required to disclose such information by law. Please
 note that AIC does not sell or provide your personal information to third parties for
 marketing purposes.

7. UPDATING YOUR INFORMATION

You may inform AIC at any time that your personal details have changed or that you wish AIC delete personal information we hold about you by emailing us . AIC will change or delete your personal information in accordance with your instructions, except to the extent that we are required to hold your personal information for regulatory or legal purposes, to provide you with the services you have requested or to maintain adequate business records.

8. LINKS

When you use this website or other service we provide to you, you may be able to link to other websites. This Privacy Policy does not apply to those sites. AIC encourages you to read the privacy policies on such sites.

9. COOKIES

AIC uses cookies to gather information about your access to this website and other services we provide to you. Cookies are small pieces of information which use a unique identification tag and are stored on your device as a result of you using this website or other service, we provide to you. Under data protection legislation, you have (subject to certain exceptions) the right to obtain copies of any personal information which AIC holds about you and to inform AIC of any inaccuracy.

If you have a request, please contact us to obtain a subject access request form.

We may charge a nominal fee to cover the cost of verifying the application and locating, retrieving, reviewing and copying any material requested.

12. YOUR CONSENT

By accessing this website or other service we provide to you, you consent to AIC collecting, maintaining, using and disclosing personal information about you and provided by you or by another person as described above.

13. AMENDMENTS TO POLICY

AlC may make changes to this Privacy and Security Policy from time to time for any reason and will notify you of such changes by posting an updated version of this policy on this website.
